This is to certify that the plants, plant product or other regulated articles described herein have been inspected and/or tested according to appropriate official procedures and are considered to be free from the quarantine pests, specified by the importing contracting party and to conform with the current phytosanitary requirements of the importing contracting party including those for regulated non-quarantine pests.

This certificate replaces and cancels PC-R0UMS9R3RY2N3Z issued on 2025-06-09 due to Addition of an item and change of traceability code.

1. The consignment complies with schedule 7 Annex 7 Part A, Point 95d of the Great Britain's Phytosanitary Regulation (2019/2072). The fruits of Solanum aethiopicum originate in areas other than those referred to in points (a) and (b), comply with point (c)(i) – (iv) and have been subjected to an effective treatment to ensure freedom from Spodoptera frugiperda (Smith). 2. The consignment complies with schedule 7 Annex 7 Part A, Point 101c of the Great Britain's Phytosanitary Regulation (2019/2072). The fruits of Solanum aethiopicum comply with the following conditions: (i) that they originate in a place of production established by the national plant protection organisation of Uganda in accordance with ISPM10 as a place of production that is free from Neoleucinodes elegantalis (Guenée), and (ii) that they are free from that pest as shown from official inspections carried out in the place of production at appropriate times during the growing season, which included an examination on representative samples of fruit, and (iii) which includes information on traceability 3. The consignment complies with schedule 7 Annex 7 Part A, Point 102c of the Great Britain's Phytosanitary Regulation (2019/2072). The Fruits of Solanum aethopicum, originate in a place of production established by the national plant protection organization of Uganda in accordance with ISPM10 as a place of production that is free from Keiferia lycopersicella (Walsingham) on the basis of official inspections and surveys carried out during the last three months prior to export. 4. The consignment complies with schedule 7 Annex 7 Part A, Point 103c of the Great Britain's Phytosanitary Regulation (2019/2072). Prior to the export of the fruits of Solanum aethiopicum, they have been officially inspected and found free from Thrips palmi Karny. 5. The consignment complies with Option (d) schedule 7 Annex 7 Part A, under point 102B of the retained Great Britain's Phytosanitary Conditions Regulation (2019/2027): the fruits Solanum melongena have been subjected to an effective systems approach to ensure freedom from Bactrocera latifrons (Hendel).
