1. The consignment complies with schedule 7 Annex 7 Part A, Point 95d of the Great Britain's Phytosanitary Regulation (2019/2072). The fruits of *Solanum aethiopicum* originate in areas other than those referred to in points (a) and (b), comply with point (c)(i) – (iv) and have been subjected to an effective treatment to ensure freedom from *Spodoptera frugiperda* (Smith). 2. The consignment complies with schedule 7 Annex 7 Part A, Point 101c of the Great Britain's Phytosanitary Regulation (2019/2072). The fruits of *Solanum aethiopicum* comply with the following conditions: (i) that they originate in a place of production established by the national plant protection organisation of Uganda in accordance with ISPM10 as a place of production that is free from *Neoleucinodes elegantalis* (Guenée), and (ii) that they are free from that pest as shown from official inspections carried out in the place of production at appropriate times during the growing season, which included an examination on representative samples of fruit, and (iii) which includes information on traceability 3. The consignment complies with Option (d) schedule 7 Annex 7 Part A, under point 102B of the retained Great Britain's Phytosanitary Conditions Regulation (2019/2072); the fruits *Solanum aethiopicum* have been subjected to an effective systems approach to ensure freedom from *Bactrocera latifrons* (Hendel).
