### 1.a

Consignment complies with Annex VII, point 68c of Commission Implementing Regulation (EU) 2019/2072. Fruits of *Solanum aethiopicum* originate in a place of production established by the national plant protection organization of Uganda as being free from *Neoleucinodes elegantalis* (Guenée) in accordance with the relevant International Standards for Phytosanitary Measures and official inspections have been carried out in the place of production at appropriate times during the growing season to detect the presence of the pest, including an examination on representative samples of fruit, shown to be free from *Neoleucinodes elegantalis* (Guenée), and information on traceability is included in the phytosanitary certificate referred to in Article 71 of Regulation (EU) No 2016/2031. The consignment meets the conditions laid down in Article 10.1c of Commission Implementing Regulation (EU) 2023/1134. The fruits of *Solanum aethiopicum* fulfill the following requirements: Prior to export the fruits of *Solanum aethiopicum* have been subject to an official inspection and found free from the *Spodoptera frugiperda* (Smith). and originate from a site of production complying with the following conditions: (i). it is registered and supervised by the National Plant Protection Organization of Uganda; (ii). official inspections have been carried out during the last three months prior to export, and no presence of the *Spodoptera frugiperda* (Smith). has been detected on the fruits of *Solanum aethiopicum*; (iii). it has physical isolation against the introduction of the *Spodoptera frugiperda* (Smith); (iv). information ensuring traceability of the fruits of *Solanum aethiopicum* to that site of production has been ensured during their movement prior to export. The consignment complies with Option (c) of Annex VII, 72.1 of Regulation (EU) No 2021/2285: no signs of *Bactrocera latifrons* (Hendel) have been observed at the place of production and its immediate vicinity since the beginning of last complete cycle of vegetation on official inspections carried out at least monthly during the three months prior to harvesting, and none of the fruits harvested at the place of production has shown, in appropriate official examinations, signs of *Bactrocera latifrons* (Hendel) and traceability information is included in the phytosanitary certificate.
